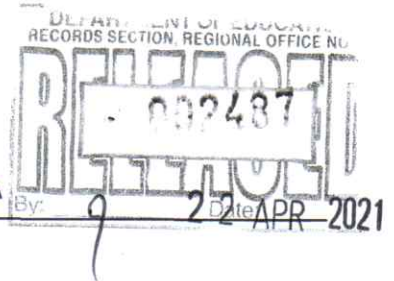

SUBJECT: **SUPPLEMENTAL GUIDELINES ON THE IMPLEMENTATION OF BAYANIHAN 2
FOR BASIC EDUCATION (BBE) PROGRAM**

This has reference to the **Implementing Guidelines on the Provision of Subsidies and Allowances to Basic Education Students under Section 4(n) of Republic Act (RA) No. 11494, otherwise known as Bayanihan to Recover as One Act**. Sevilla issued these supplemental guidelines to ensure timely processing of applications and release of payments for subsidies and allowances on or before June 30, 2021 for qualified private and public basic education learners.
