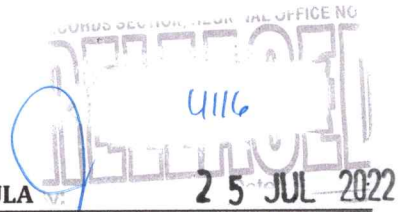

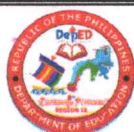

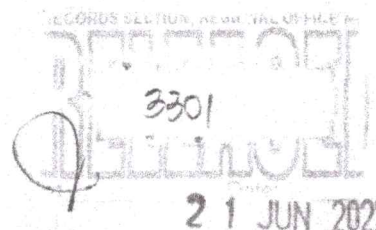

MASS TRAINING OF ALS TEACHERS ON THE IMPLEMENTATION OF ALS ACT AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR)

To: Schools Division Superintendents
This Region

1. The Department of Education, Zamboanga Peninsula Region, through the Curriculum and Learning Management Division (CLMD) will conduct the Mass Training of ALS Teachers on the Implementation of ALS Act and Its Implementing Rules and Regulations (IRR) on August 8-9, 2022 for batch 1 and August 11-12, 2022 for batch 2 at Zamboanga del Norte.
2. The objectives of the Mass Training are to:
 - a. orient ALS teachers on the salient features of the ALS Act and its Implementing Rules and Regulations and train them to advocate and implement the ALS Act and its IRR;
 - b. define the roles and responsibilities of different DepEd governance levels in the implementation of the law; and
 - c. gather the commitment of both DepEd field officials and personnel for the operationalization of the ALS Act.
