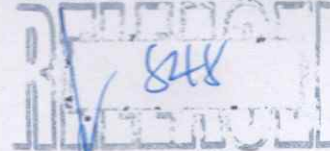

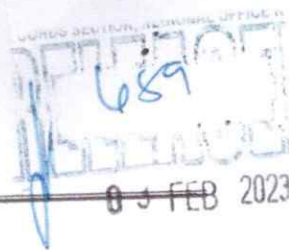

**CONFERENCE OF CURRICULUM AND TEACHING CHIEFS AND READING SUPERVISORS ON THE RAPID APPROACH IMPLEMENTATION**

To: Schools Division Superintendents

This Region

1. It has reference to RM 16, s. 2023, titled Initial Policy Guidelines on the Implementation of RAPID Approach to Learning Recovery of Region IX, the Curriculum and Learning Management Division (CLMD), in partnership with the Schools Division Office (SDO) of Zamboanga City, will conduct the **Conference of Curriculum and Teaching Chiefs and Reading Supervisors on the RAPID Approach Implementation** on February 27-28, 2023 in Zamboanga City.
2. The activity aims to achieve the following objectives:
  - a. Show understanding of the Reading Component of the RAPID (Reading and Numeracy First, Assessment, Profiling, Increase, Develop) Approach to Learning Recovery of Region IX;
  - b. Develop the specific guidelines on the implementation of reading innovations as stipulated in Components 1 to 5 of the RAPID Approach Policy;
  - c. Provide updates on the SDOs' accomplishments in the promotion of literacy in schools; and
  - d. Discuss the initial revised guidelines and categories of the National Schools Press Conference (NSPC) 2023.
- e. This convergence includes the Chiefs of the Curriculum and Teaching Division, Education Program Supervisors in English and Filipino, and the Division Reading and ELLN Coordinators. (See Annex A for the List of Participants.)
- f. The event shall be **lived out**. The first meal is breakfast on Day 1, and the last is dinner on Day 2. (See Annex B for the Conference Matrix.)
- g. Each SDO shall present its Programs, Projects, and Activities (PPAs) on Reading and the ELLN for the Fiscal Years 2022 and 2023. Videos, photos, and other documentation may be included in the presentation provided the whole report shall be at most 15 minutes. (See Annex C for the Template.)
- h. The specific venue shall be announced through an Advisory.
- i. Participants shall bring their extension wires, laptops, and Internet modem for the workshops.
- j. Any identified participant who cannot make it in the said schedule shall write this Office a justification of such absence.
