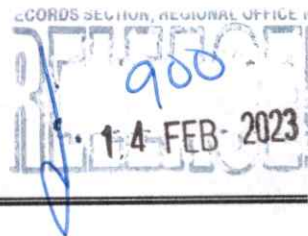

 - b. Craft a Reading Assessment Tool for Arabic Language for Key Stage 1 (Kinder to Grades III) that will measure the reading ability of the Muslim Learners. Production will be done after quality assurance process.
 - c. Conduct Upskilling and Retooling for all MEP-COS /Regular Teachers to enhance Teaching Capabilities for quality learning outcomes of Arabic Language and Islamic Values Education. (at least 3-4 trainings for FY 2023).
 - d. Workshop on Skills Enhancement/ Arabic Emergent Reading (AERCA) for School Heads on the Implementation of Madrasah Education Program (MEP).
 - e. Asatidz participation in Brigada Eskwela, World Teachers Day Celebration and In-service Training INSET and other school/division related activities.
