KUMUSTAHAN: DEPED RO IX COMPLIANCE WITH GAD LAWS AND MANDATES CUM COACHING FOR GAD ATTRIBUTION ACROSS FUNCTIONAL DIVISION ACTIVITIES

- 1. In reference to Women's Magna Carta, the Philippine state is responsible for ensuring women's rights and opportunities are equal to men. The said law identified strategies to enforce the policy: (1) setting aside and utilizing a substantial portion of official development assistance funds to support programs and activities for women; (2) ensuring that women benefit equally and participate directly in the development programs and projects of all government departments; and (3) gender mainstreaming or removing gender bias in the regulations, circulars, issuances, and procedures of all government departments and agencies.
- 2. Moreover, the Gender and Development Budget Policy was established by the General Appropriations Act (GAA) as the "Women's Budget" to focus on gender advocacy and women's empowerment efforts using natural resources, assist in the implementation of programs and projects, and directs all government departments and agencies to allocate at least five percent (5%) of their total annual budget to gender equality programs, projects, and activities. The said provisions are vital features of the yearly GAA and were further reinforced by the Women's Magna Carta (RA 9710).
- 3. To support this, DepEd RO IX will conduct "Kumustahan: DepEd RO-IX Compliance with GAD Laws/Mandates cum Coaching for GAD Attribution across RO Functional Division Activities on May 15, 2023, at DepEd NEAPR, Tiguma, Pagadian City.
- 4. The activity aims to:
  - a. Integrate GAD attributions into Functional Division activities; and
  - b. Establish compliance with GAD activities in ROI curriculum endeavors.
- Immediate dissemination of this memorandum is desired.
