Dear Director Fuentes:

We are pleased to inform you that per the FY 2022 Performance Based Bonus (PBB) Final Eligibility Assessment (FEA) Report of the Administrative Order (AO) 25 Inter-Agency Task Force (IATF), the DepEd achieved 75 points and is eligible for the grant of the FY 2022 Performance Based Bonus (PBB), based on the submitted Report on Ranking of Offices/Delivery Units (Form 1.0) of the personnel in the DepEd-Regional Office IX and Schools Division Offices (SDOs).

Following the results of the FEA Report, the eligible officials and employees of the DepEd shall each receive a PBB equivalent to 48.75 percent of the respective monthly basic salary as of December 31, 2022, provided further that those belonging to the First, Second and Third levels received a rating of at least "Very Satisfactory" based on the agency's Civil Service Commission approved Strategic Performance Management System or the requirements prescribed by the Career Executive Service Board.

Please note that per the aforementioned FEA Report, the unit/s most responsible (including its head) for the criteria stated in Sections 3.0 and 5.0 of Memorandum Circular (MC) No. 2022-11, i.e., performance rating of below 4, and non-compliance with Agency Accomplishments (PhilGEPS Posting, Submission of FY 2022 Non-Common Use Supplies and Equipment, and Undertaking of Early Procurement Activities covering 2023 Procurement Projects), should be isolated from the grant of the FY 2022 PBB. Hence, in compliance with the aforesaid findings of the AO No. 25 IATF, 1 employee of the Regional Office IX and 40 employees of the SDO's have been excluded from the DepEd-RO's FY 2022 PBB ranking.

In this regard, the total amount required for the payment of the FY 2022 PBB to 115 and 1,275 personnel of the DepEd-Regional Office IX and SDOs are P2,376,747.15 and 22,423,521.71, respectively, subject to compliance with all other requirements and conditions on the grant thereof.

However, with the depletion of the FY 2024 MPBF, funding for the purpose shall be charged against available PS allotment, consistent with item 5.1.3 of NBC 592².

As represented and confirmed by the DepEd Central Office in an email dated December 17, 2024, your agency has sufficient PS allotment to fully cover the funding requirements for the FY 2022 PBB. Therefore, the issuance of a Special Allotment Release Order (SARO) for this purpose is **no longer necessary**.
