Invitation to Assist DEPED Comply with the Provisions of Republic Act 11285

Energy Efficiency and Conservation (EE&C) Act

#### Dear Secretary Angara:

I hope our letter finds you well.

We are from Meralco Power Academy (MPA), the research and academic arm of MERALCO, and we were commissioned by the Department of Energy (DOE) to implement the Government Energy Management Program (GEMP) specifically the IAEECC Resolution No. 1, Series 2020 that states as follows:

"Directing All Government Agencies, including the Local Government Units (LGUs) and Foreign Service Posts, to Comply with the Government Energy Management Program (GEMP), Ordering the Department of Energy to Conduct Energy Audits and Spot checks, and Submit Proposed Improvements to the GEMP"

The said resolution, in summary, mandates all Government Entities (GEs) to perform the following tasks for them to be declared as compliant with the GEMP:

- Designation of Energy Efficiency and Conservation Officer and Energy Efficiency and Conservation Focal Person
- 2. Setting the thermostat of AC units to 24 degrees Celsius
- 3. Conduct of energy audit, surveys, technical analysis, and other research activities
- 4. Improvement of Government Energy Management Program
- 5. Submission of Monthly Electricity and Fuel Consumption Report

Through a government contract with DOE, MPA was deputized (please see Attachment 1) to perform Item 3 above to forty-four (44) identified (GEs) located in Region IX. Out of the 44 GEs, the following DEPED institutions were included by DOE to become part of the mentioned energy audit (review) namely,

- a. Department of Education Schools Division of Zamboanga del Norte
- b. Department of Education Schools Division of Dipolog City
- c. Department of Education Schools Division of Dapitan City
- d. Department of Education Regional Office IX Zamboanga Peninsula

Prior to conducting the energy audit, MPA requested from DOE to extract from their GEMP Online system the Schools Divisions' compliances with Items 1 and 5 of the said resolution and the results are as follows:



- Department of Education Schools Division of Zamboanga del Norte (Not Compliant with Items 1 and 5)
- b. Department of Education Schools Division of Dipolog City (Not Compliant with Items 1 and
   5)
- Department of Education Schools Division of Dapitan City (Not Compliant with Items 1 and
   5)
- Department of Education Regional Office IX Zamboanga Peninsula (Compliant with Item 1, Not Compliant with Item 5)

We understand that there may be several issues, difficulties and valid reasons for above DEPED institutions' inability to comply with the GEMP and the issued IAEECC Resolutions (please see Attachment 2).

Given the above predicament, MPA plans to integrate a positive approach to this energy audit by launching a series of Workshops to help these 44 GEs respective institutions catch up with their compliances with the requirements of the GEMP prior to the actual energy audit. Moreover, it will still be dependent on the said institution and support accorded to them as regards to their success on these added catch-up plans we will provide.

To wit, the said On-Line Workshops will assist these GEs by giving them a refresher course on what is the GEMP all about and a continuing hand-on guided course workshop using their own computers designed to guide them on how to use the GEMP Online Submission System and how to submit the required data like the Monthly Electricity and Fuel Consumption Reports being required of them by the law. Succeeding activities with the way forward will be coordinated with appointed representative, preferably with your Energy Efficiency and Conservation Officer (EECO) if you have one appointed already for each institution, or you may appoint one who shall represent and be incharge with the said compliances to the DOE.

In this regard, we humbly request your office to provide us the names and contacts of the 3 remaining DEPED institutions mentioned above (please see Attachment No. 3). Since, the workshop will be done thru online sessions and will be free of charge to the participants, you may extend our invitation to other DEPED School Principals or Administrative personnel as additional learning for them too. This will be beneficial for their energy management awareness compliances and will also properly prepare them on the next batch of energy audits that DOE may conduct in the future for Region IX.

As an extra effort on our part to ensure successful implementation of the DOE's GEMP, we will issue an e-certificates to all attendees who will successfully finish the workshops. However, please note that after the workshops, MPA will already proceed and conduct the energy audit/review for the DEPED institutions listed above by DOE.




