CONDUCT OF DEVELOPMENT, VALIDATION, AND FINALIZATION OF SELF-LEARNING MODULES IN ENGLISH FOR GRADES 2, 3, 5, AND 8

1. In line with the implementation of the Revised K to 10 Curriculum, the DepEd Regional Office IX, Zamboanga Peninsula through the Curriculum and Learning Management Division (CLMD) will spearhead the **Conduct of the Development, Evaluation, and Finalization of Self-Learning Modules in English Grades 2, 3, 5, and 8**.
